Before his tenure at Ways and Means, Alex was an economist at the White House Council of Economic Advisers, where he provided advice and analyses on national and international economic policies for the president. In 2010, Alex served as a consultant advisor to the President's Fiscal Commission

(commonly known as the Bowles-Simpson Commission). Alex is also a senior fellow at the American Enterprise Institute.
