He began his legal career in Maryland, as in-house counsel for Dun & Bradstreet Healthcare Information Services, a consulting and management corporation specializing in the development and operation of managed care programs such as preferred provider organizations and health maintenance organizations. In addition to his corporate duties as in-house counsel, he negotiated managed care contracts with hospitals and physicians in over fifty managed care networks across the country.
