Her long involvement in public health predates her legal career, with an extensive policy and advocacy background informing her current practice, especially regarding Medicaid payment rates and disputes.

Erin is also actively involved in litigation in federal court and at the trial and appellate levels in California, including responding to requests for temporary restraining orders and other emergency motions.

Prior to attending law school, Erin worked in diverse health care advocacy and policy roles, including founding a consulting practice focused on Medicaid advocacy in Florida, teaching policy to social work graduate students at the University of South Florida, and serving as a legislative affairs associate for a national hospital trade association in Washington, D.C.

Erin’s subsequent academic career was equally focused on health policy. In law school, she served as a judicial extern in the Northern District of California, was a research fellow at the UCSF/UC Hastings Consortium on Law, Science, and Health Policy, and was a legal intern for the Harvard Law School

Center for Health Law and Policy Innovation. She graduated *summa cum laude* and Order of the Coif from the University of California, Hastings College of the Law and served as the president of the Hastings Health Law Organization.
